FEE SCHEDULE

The CoA-END considers distance education programs and seated programs as two separate, individual programs. The CoA-END reviews the programs separately and makes separate accreditation recommendations to CAAHEP. Distance education programs are defined as those in which students are not required to step foot on campus for instruction. PROGRAMS THAT OFFER BOTH SEATED AND DISTANCE EDUCATION PROGRAMS ARE RESPONSIBLE FOR THE FOLLOWING FEES FOR BOTH THE DISTANCE EDUCATION PROGRAM AND SEATED PROGRAM.

- * The actual cost of site visits includes airfare, hotel, ground transportation, meals, and incidental expenses. It is recommended that programs budget approximately \$1500-\$2000 for site visit expenses.
- * The annual fee is charged after Initial Accreditation has been granted. Programs receiving Initial accreditation between January–June of a given year are responsible for payment of the total annual fee. Programs receiving accreditation between July-December of a given year are responsible for payment of 50% of the annual fee. Following the initial invoice for the annual fee, programs are invoiced in January of each year for the annual fee.

Continuing Accreditation

- * Programs are invoiced in January of each year for the annual fee.
- * Programs notifying the CoA-END (in writing) of an intention to discontinue prior to July 1 of a given year are invoiced 50% of the annual fee for that year. Programs discontinuing July 1 or later in a given year are responsible for payment of the total annual fee.
- * Inactive accredited programs must pay the annual fee to maintain accreditation.

**The Commission on Accreditation of Allied Health Education Programs (CAAHEP) charges a \$450 institution fee to institutions that have one or more CAAHEP-accredited program(s).*
